## About the Benchmark

A benchmark provides an investor with a point of reference to evaluate an investment's performance. A common type of benchmark used to compare investment performance is called an index. Indexes are unmanaged portfolios of securities designed to track the performance of a particular segment of the market. For example, a large cap stock fund or account will usually be compared to an index that tracks a portfolio of large-cap stocks.
