TIAA Traditional is designed primarily to help meet your long-term retirement income needs; it is not a short-term savings vehicle. #### **About the Benchmark**

A benchmark provides an investor with a point of reference to evaluate an investment's performance. One common type of benchmark used to compare investment performance is called an index.
